General marking principles for Advanced Higher Graphic Communication

Always apply these general principles. Use them in conjunction with the specific marking instructions, which identify the key features required in candidates' responses.

- (a) Always use positive marking. This means candidates accumulate marks for the demonstration of relevant skills, knowledge and understanding; marks are not deducted for errors or omissions.
- (b) If a candidate response does not seem to be covered by either the principles or detailed marking instructions, and you are uncertain how to assess it, you must seek guidance from your team leader.
- (c) For 'Describe' questions
Candidates must provide a statement or structure of characteristics and/or features, not just an outline or a list. For example they can refer to a concept, experiment, situation or facts in the context of and appropriate to the question. The number of marks available for a question indicates the number of factual/appropriate points required.
- (d) For 'Explain' questions
Candidates must relate cause and effect and/or define relationships. This must be in the context of the question, or a specific area within the question.
- (e) For 'Compare' questions
Candidates must demonstrate knowledge and understanding of the similarities and/or differences between things, methods, or choices. This must be in the context of the question, or a specific area within the question.
- (f) Candidates can respond to any question using text, sketching, annotations or combinations of these. Award marks for the information conveyed. Do not award marks for the quality of sketching.

(c)	<p>Image Resolution:</p> <ul style="list-style-type: none"> • 150 dpi (in this example) is the minimum required resolution to ensure the correct print quality • High resolution or vector files can be scaled without loss of resolution • The resolution must be clear enough to check the design on screen <p>File types</p> <ul style="list-style-type: none"> • JPEG allows the company to reproduce photographic images: this is a smaller file size than other types but still has the required quality for images of photos • TIF has the advantage of lossless compression, transparency and allows different layers within an image • SVG or other vector file for logos etc... so that these can be scaled without loss of quality • EPS or other suitable vector file for text • AI for the logo to ensure scalability/high quality at different sizes <p>Colour space:</p> <ul style="list-style-type: none"> • CYMK is preferable as it is used for print • the company will accept RGB as customers may only be seeing colours on screen. The company will then convert these to CYMK for printing • Pantone colours will be useful because the company will check the design against the pantone colours to ensure correct matching 	8	<p>Candidates can achieve full marks by mentioning 8 valid points from any category (resolution, file types, colour space, CAD/CAM).</p> <p>A simple statement will not gain marks as an explain response is required.</p> <p>Only accept a PNG (file types response) if the candidate states it will need to be converted to a PDF or vector file for printing. PNG is not generally a suitable file type for printing.</p> <p>Only accept answers that relate to file types mentioned in the print guidelines.</p> <p>Accept:</p> <ul style="list-style-type: none"> - pdf files help the company because they can be easily opened and are small file sizes for storage/downloading. - The colour chart can help the company because it ensures printing accuracy and shows customer what to expect / reduces likelihood of customer complaints. - 'Converting all fonts to outlines' ensures the company will be able to print any text (independent of the original text file)
